# PART A

## 1.0 Preamble:

- 1.1 The total Lump Sum Contract price as provided in item 2 below, shall remain fixed and firm and shall not be subject to revision or escalation during the duration of the Contract for any reason whatsoever, including but not limited to currency fluctuation or wages and other prices changes.
- 1.2 Contractor shall be deemed to have familiarized himself with physical nature of the work & work sites and all other matters pertinent to the execution of the works. The Lump Sum price included in this Exhibit shall be deemed to include sufficient allowance for the implementation of the scope of work as well as for all the factors influencing the cost including but not limited to those mentioned in clause 1.1 here above.
- 1.3 The rates shall be inclusive of all commissions or fees or charges payable to Contractor's agents and consultants.
- 1.4 The price includes for provision of all necessary equipment and tools required for carrying out the scope of work.
- 1.5 The total Lump Sum Contract price stated bellow is the full payment to be made to the Contractor for completion of all works and furnishing all the services required under the contract.
- 1.6 Prices include for all direct and indirect costs incurred due to complying with the requirement of the Contract, including but not limited to wages, per deems, overheads, profits, applicable taxes and duties & any other levies applied inside /or outside Sudan.

Payments shall be made for the satisfactory performance of the respective milestones, against due certification by PETCO representative, within 30 days of receipt of respective invoices, supported by all necessary documents, duly signed by PETCO representative, wherever necessary.
