Your offer shall be prepared in English.

Please submit your offer using the Annexes provided. Offers not conforming to the requested formats may not be taken into consideration.

2.4.1 Content of the TECHNICAL OFFER

IMPORTANT:

No pricing information should be included in the technical offer. Failure to comply may risk disqualification. The technical offer should contain all information required.

Statement of Work (SOW) for **the upgrading, rehabilitation, and solarization of a water distribution network in Gebeish Town, West Kordofan, Sudan** can be found in **Annex A.** Your technical offer should be concisely presented and structured in the following order to include, but not necessarily limited to the following information:

 - A. Curriculum Vitae of core staff and their qualifications with the company organizational chart
 - B. Demonstrated similar projects successfully completed and/or currently ongoing/similar projects currently underway.
 - C. Experience with similar works with a list of references
 - D. Detailed proposal showing that the company understands requirements set out in the SOW and demonstrates technical methodology taken for selection of units including illustrations. That includes Sound Solarization unit design and sizing, quality of Pipelines, Solar PVC and batteries, submersible pump, generator, and solar support structures design
 - E. A clear implementation methodology that follows the technical methodology, shows how the company shall fulfill the requirement as set out in the SOW while complying with the high standards. That includes conformity of proposed components of the water yard rehabilitation/upgrading and solarization to the minimum technical specifications in the SOW, availability of equipment for executing the work (plumping, construction, and solarization), and quality of proposed Solarization, construction, and plumbing materials. The products datasheet for the proposed supplies and equipment.
 - F. Commitment to complete works in desired timeframe (Detailed work plan including proposed time schedule)
 - G. List of equipment owned by the firm to be mobilized for the execution of works described in Annex (A)
 - H. Demonstrated previous experience and performance records with other UN Agencies, NGOs, or any other major clients and other credentials.
 - I. Project assumptions and constraints based on your understanding of the project.
 - J. The methodology/approach to be used in addressing the issues outlined in the SOW.
 - K. Audited financial reports (balance sheets and income statements), and bank statements for the last (03) three years.
 - L. Any information that will facilitate our evaluation of your company's substantive reliability, financial and managerial capacity to provide the requested requirements by UNHCR as specified in Annex A.

Award and bank guarantee:

The Firm that submits the successful Proposal will be notified by "Letter of Award" prior to the expiration of the validity period. The letter, referred to as the "Letter of Award" will state the sum of the fees to be paid to the Firm for the services rendered and will indicate the terms under which the Contract must be finalized. The Contract must be signed within 14 days of the issuance of the Letter of Acceptance. The successful bidder will be required to furnish UNHCR with a 5% Bank Guarantee of the contract value from a reputable bank in the next 7 days, valid for the entire period of the contract works.

2.4.2 Content of the FINANCIAL OFFER

Your separate Financial Offer must contain an overall offer in United States Dollars (USD). The financial offer must cover all the services to be provided (price "all-inclusive"). If no financial offer is received, the bid shall be automatically disqualified. For evaluation purposes only, the offers submitted in currency other than US Dollars will be converted into US Dollars using the United Nations rate of exchange in effect on the date the submissions are due.

The Financial Offer is to be submitted as per the Financial Offer Form (Annex C). Bids that have a different price structure may not be accepted.

UNHCR is exempted from all direct taxes and customs duties. With this regard, the <u>price has to be given</u> <u>without VAT</u>.

You are requested to hold your offer valid for a minimum of **90 days** from the deadline for submission. UNHCR will make its best effort to select a company within this period. UNHCR's standard payment terms are within 30 days after satisfactory implementation and receipt of documents in order.



The cost of preparing a bid and of negotiating a contract, including any related travel, is not reimbursable nor can it be included as a direct cost of the assignment.

IMPORTANT: UNHCR can only facilitate payments through the local banks and not banks outside of Sudan and therefore the current market condition must be factored in before submitting your quote.

The financial offer signed and stamped is to be sent separately from the technical offer

2.5 BID EVALUATION

2.5.1 Supplier Registration:

The qualified company (s) will be added to the Vendor Database after investigation of suitability based on the submitted Vendor Registration Form and supporting documents. The investigation involves consideration of several factors such as:

- Financial standing.
- Core business.
- Track record.
- Contract capacity.

2.5.2 Technical and Financial evaluation:

For the award of this project, UNHCR has established evaluation criteria that govern the selection of offers received. Evaluation is made on a technical and financial basis. The percentage assigned to each component is determined in advance as follows:

- Technical Offer will be weighed at 60 points (or 60%)
- Financial Offer will be weighed at 40 points (or 40%)

The Technical offer will be evaluated using inter alia the following criteria and percentage distribution: **60%** of the total score, with **a minimum passing score of 36 points**.

The Minimum Score to be considered technically compliant is 60 points out of max of 100 technical points (60%). Proposals that score below 36 points will not be considered in the financial evaluation nor for the award of the contract.

2.5.4 The Financial offer will use the following percentage distribution: 40% of the total score.

The maximum number of points will be allotted to the lowest price offer that is opened and compared among those invited firms. All other price offers will receive points in inverse proportion to the lowest price, e.g., [total Price Component] x [US\$ lowest] \ [US\$ other] = points for other supplier's Price Component. For evaluation purposes only, the offers submitted in currency other than US Dollars will be converted into US Dollars using the United Nations rate of exchange in effect on the date the submissions are due.

UNHCR may, at its discretion, extend the deadline for the submission of bids, by notifying all prospective suppliers in writing. The extension of the deadline may accompany a modification of the solicitation documents prepared by UNHCR at its own initiative or in response to a clarification requested by a prospective supplier.
