Project Description	The NGO <i>World Vision</i> has received financing from the German Development Bank (KfW) for the <i>Livelihoods and Agricultural Infrastructure Development (LAID) Project</i> in South Darfur, in order to contribute to increased stability and economic well-being of conflict affected people and vulnerable communities. One of the Project objective is to provide improved access of pastoralists and agro-pastoralists to basic services and infrastructures for improved livestock, dairy and honey production.

<p>Financing</p>	<p>The overall Project value of EUR 11 Mio. is financed by a grant of the Federal Republic of Germany via the KfW Development Bank and a contribution of World Vision Germany. The estimated investment costs for the construction and equipment of the veterinary clinics and honey processing centres is estimated to amount up to EUR 1 Mio. (excluding the costs for consulting services).</p>
