**Vendor Registration Form:** If your company is not registered with UNHCR or have not been active or have not received a UNHCR PO for more six (6) months, you should complete, sign and submit with your technical proposal the Vendor Registration Form (Annex C).


**Bids received after the deadline for submission of bids and bids transmitted in any other manner than those indicated above may not be considered.**
