The Office of the United Nations High Commissioner for Refugees (UNHCR), established on December 14, 1950, by the United Nations General Assembly¹, requests your price quotation for the attached **Essential list of Medicine** specified in this Request for Quotation (RFQ).

1. REQUIREMENTS

The following details which comprise part of the mandatory requirements, eligibility and qualification criteria **should be provided as part of your offer with this tender**. find the description of medicines, detailed with technical specification, and quantities to be ordered in Annex A named List of Essential Medicines.

- **Registration of Firm**: The bidder must provide copies of registration documents in Sudan as medicines supplier approved by the Ministry of Health.
- Description: Goods Essential Medicine, the technical details of the required products can be found in Annex B. The medicines shall provide shall be manufactured by WHO approved pharmaceutical companies with proof of WHO Good Manufacturing Practices (GMP) and/or WHO Good Distribution Practices (GDP) / Good Storage Practices (GSP) Certificates.
- Experience: The Supplier/Company must provide a sample PO or contract on the supply of medicines in Sudan including contact details of the clients who received the goods.
- **Important Attention**: The highlighted medicines in yellow and items need 2-8 c degree temperature are required cold chain while transporting and the company to guarantee safe arrival to the location in El Daein.
- The shelf life of items should be minimum of 18 months.
- **Quantity**: As per attached Excel File and applicable packing units.
- Delivery Point: UNHCR East Darfur/State Ministry of Health in El Daein,
- **Delivery time**: (After receipt of order): 21 days after issuing of the order.

This tender is for suppliers within Sudan. If suppliers have to import the goods, UNHCR shall not be in the position to facilitate the import approval and/or custom processes. Importation and delivery in El Daien is the sole responsibility of the supplier.

- 3. <u>Financial Offer:</u> Please submit your price offer, using the financial Offer part in Annex B named (to be filled by the suppler). Your offer must be in SDG or USD. Your prices must be inclusive of costs like production, labour, overhead, exchange rates and other risks, transportation up to State Ministry of Health El Daien etc. UNHCR shall not accept any requests for additional payments after reception of your offer. Please Ensure that your financial offer does not have cancelations or corrective fluid on it. Any offer with corrective fluid shall be disqualified.
- 4. <u>Award Criteria:</u> The lowest priced, substantially compliant offer will be recommended for a contract award.

Your quotation must be valid for at least 30 calendar days. The standard payment terms of UNHCR are net 30 days upon satisfactory delivery of goods or services and acceptance thereof by UNHCR.
