PAYMENT: Payment will be made within 30 days of receipt in UNHCR, Gedaref office of complete documents in good order after satisfactory delivery of goods/services. UNHCR does not undertake to pay by letters of credit or in advance of delivery.

CURRENCY OF PAYMENT: Payment will be made in the currency in which the purchase order is issued.

IMPORTANT: UNHCR Primary Bank is the Blue Nile Meshrag Bank and therefore can only facilitate payments through the local banks and not in banks outside of Sudan. Therefore, the current market condition and Central Bank of Sudan regulations and policies must be factored in before submitting your quote.

<u>Vendor Registration Form:</u> If your company is not registered with UNHCR or have not been active or received a UNHCR PO for within the last six (6) months, you should complete, sign and submit with your technical proposal the Vendor Registration Form (Annex C).
