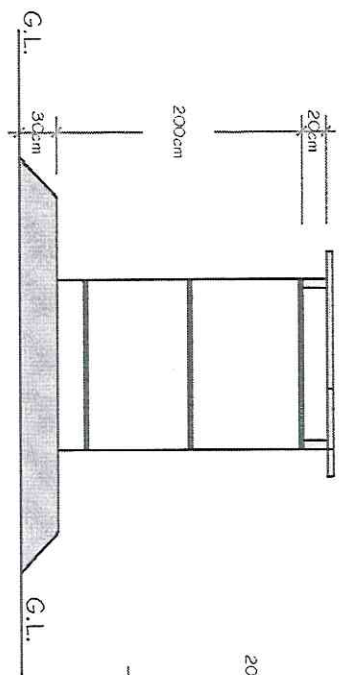

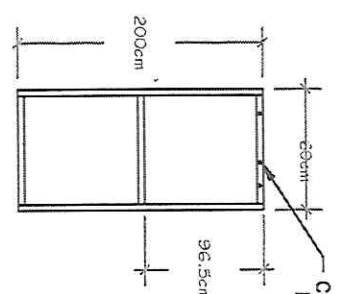

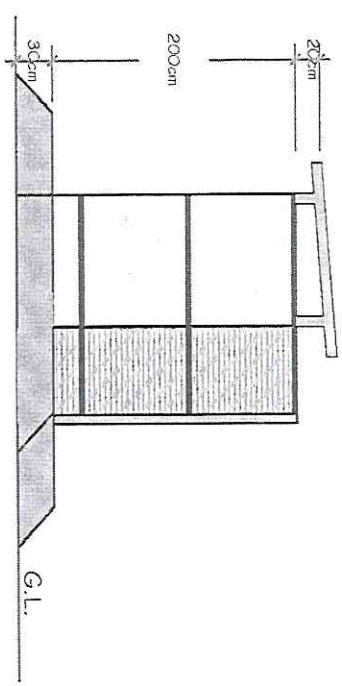


ELEVATION - C -

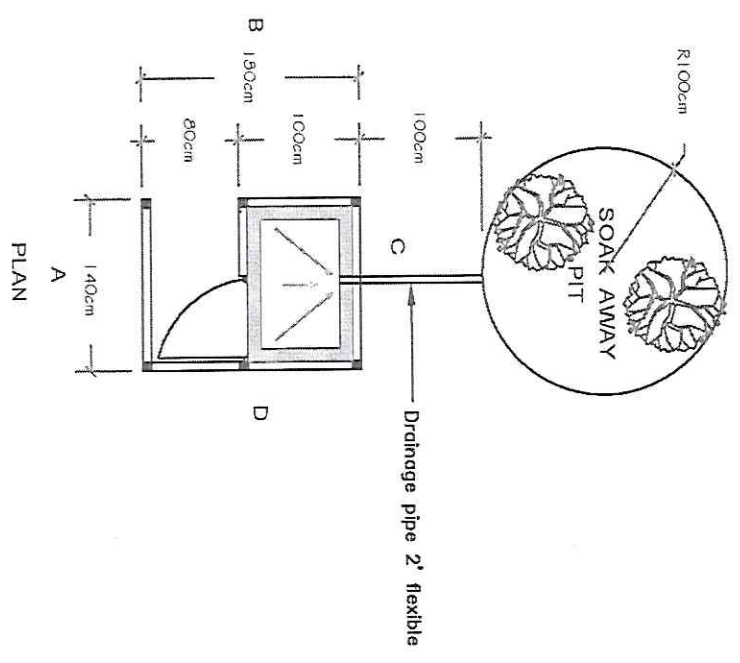


Typical door shutter

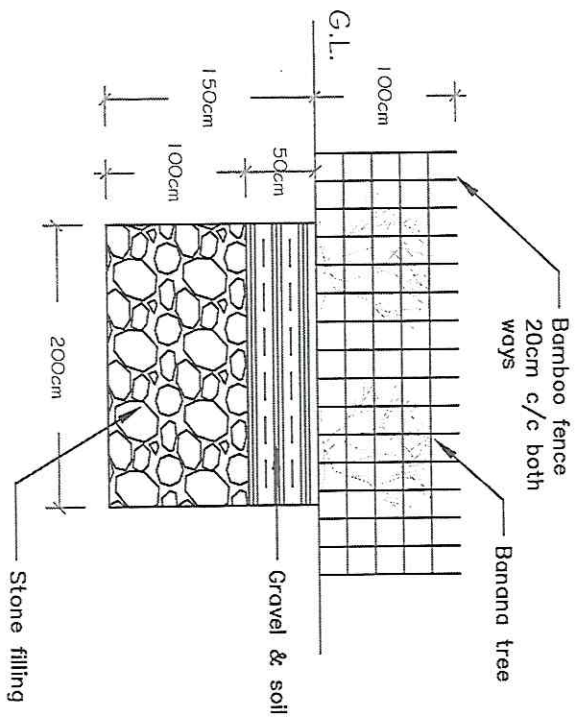

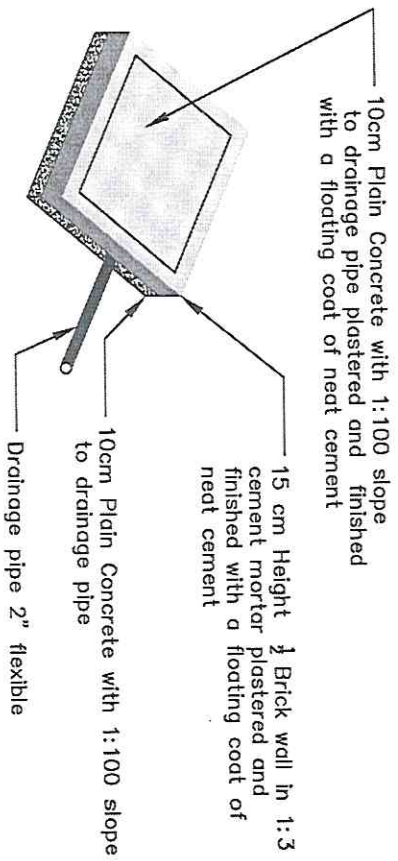
