1. ITB form should be printed, signed, dated and stamped.

2. All pages of the ITB should be signed and stamped.
3. Ensure no alterations on numbers included in the Price quotation list.
4. No White wash or deletion is accepted on the Price quotation list.
5. Bids should be strictly quoted in SDG only.

Additionally note that:

- a) Bidders shall observe the highest standard of ethics during the procurement and execution of contracts. WR will reject a Bid if it determines that the Bidder recommended for award, has engaged in corrupt, fraudulent, collusive, or coercive practices in competing for, or in executing, the Contract.
