1. PURPOSE OF THE AMENDMENT

Afaq for Justice and Development Organization hereby issues this Amendment No. 01 to ITB-AFAQ-2026-DAMAZIN-01 for the Rehabilitation and Maintenance of the Civil Registry Centre and Civil Status Office – Damazin.

This Amendment forms an integral part of the Invitation to Bid (ITB) and shall be read together with the original ITB and all its annexes. Bidders shall take the amendments below into consideration when preparing and submitting their bids.

2.1 AMENDMENT TO THE BID SUBMISSION DEADLINE

Section 7 – Submission Deadline and Method of the original ITB is hereby amended as follows:

Accordingly, all references in the ITB and its annexes to the bid submission deadline of 25 August 2026 shall be read as 27 August 2026 at 4:00 pm Sudan local time.

3. AMENDMENT TO THE BID SECURITY REQUIREMENT

Annex 7 – Bid Security / Bid Bond Format is hereby amended to reduce the required bid security from 5% to 2% of the total bid amount.

Item	Original Requirement	Amended Requirement
Bid Security / Bid Bond	5% of the total bid amount	2% of the total bid amount

The Bid Security / Bid Bond shall therefore be issued for an amount equivalent to 2% of the Bidder's total bid amount.

4. AMENDMENT TO ANNEX 7 – BID SECURITY / BID BOND FORMAT

The wording in Annex 7, Section beginning "We, [Bank Name]..." is amended so that the Guaranteed Amount shall not exceed 2% of the total bid amount, instead of 5%.

Amended wording:

"We, [Bank Name], of [Bank Address], hereby irrevocably undertake to pay the Beneficiary, upon its first written demand and without cavil or argument, any sum or sums not exceeding in total SDG [2% of the total bid amount] (the "Guaranteed Amount")..."

5. EFFECTIVE DATE AND STATUS OF THIS AMENDMENT

This Amendment is effective from the date of issuance and forms an integral part of ITB-AFAQ-2026-DAMAZIN-01.

In the event of any inconsistency between this Amendment and the original ITB or its annexes, the provisions of this Amendment shall prevail.

6. CONTINUING VALIDITY OF THE ORIGINAL ITB

Except for the changes expressly stated in this Amendment, all other terms, conditions, specifications, instructions, requirements, evaluation criteria, and provisions of the original ITB remain unchanged and in full force and effect.
